Four equal payments are due September 15, 2023, November 15, 2023, January 15, 2024, and March 15, 2024. If you choose to pay in cash or check, please take \$25 off each of your quarterly payments. There will be a \$25 fee added onto any late payment. **Please note that the current seasonal discounts will exist for the next 2 years. Beginning on May 1, 2026, Seasonals that began camping at Maple Park prior to 2016 will receive a 15% discount off the 2026 Maple Park seasonal fee. All other Seasonals will pay the 2026 seasonal fee.**
